

## Electrical Maintenance Operator Training (IH-E), Gehring L-Series - Course No. A100009

---

### Short Description

This course provides the technical fundamentals of proper maintenance and repair for the electrical control system of the Gehring L Series machine. Focus is laid on the operation and workings of the Gehring Honing Control (GCU) as well as the driveshaft technology, exchange and set up of the GCU axis as well as the proper approach to the diagnosis and correction of electrical faults.

### Course Objectives

- Diagnosis and correction of electrical controls errors
- Performance of electrical controls maintenance tasks (L-Series)
- Diagnosis and correction of electrical faults ( L-Series)

### Prerequisites

Qualified electrician or comparable authorization to work on electrical controls. Knowledge of safety regulations, PLC programming experience (Siemens S7) and general NC knowledge. Prior participation at course A10000 „Operator Training - Module 1 (Basics)“.

### Target Group

Maintenance electricians as well as service personnel with electrical maintenance duties.

- Safety
- Presentation of the machine
- Presentation of the component groups and the controls
- Expansion control and air gauging systems
- Hardware and software platforms (set up, structure and function)
- Diagnostics and preventative maintenance ( troubleshooting, procedures and tools)
- Changing out components ( Hardware exchange- except for/excluding Bosch Indradrive)
- Dealing with the technical documentation
